# TOWNSHIP OF MONROE Board of Fire Commissioners Fire District No. 2 Minutes of the Regular Meeting Wednesday, October 16, 2019

The Monroe Township Board of Fire Commissioners of District No. 2 met at the Monroe Township Fire District #2 & EMS building, 10 Halsey Reed Road, Monroe Township, New Jersey for the Regular Meeting.

# APPLEGARTH VOLUNTEER FIRE COMPANY

Chairman Martin asked for a report from the volunteers. Commissioner Frisch thanked Jennifer and Hank and attending tonight and for their participation when the board member attended their last volunteer meeting

Hank requested a few things: Equipment needs to be looked at (thermal imaging camera); install mounting bracket in pickup truck to hold SCBA, in case they respond using that vehicle; many IDs have expired and new firefighters have come onboard - what is needed to get new IDs/accountability tags. Commissioner Borsuk stated there is a sheet at the firehouse, and Chief Carbin said he will need pictures in front of the flag. Chief Carbin can address all these items.

Jennifer asked if the Chief can let them know when they are doing training. He can either use Gary or Hank as a point of contact. Chief mentioned the extrication training is for on duty shift and volunteers.

Chairman Frisch stated it's important to keep lines of communication open if volunteers are not available for calls.

Hank asked if he can be shown how to update the app (I am Responding), and he will share with the volunteers. Hank also stated there are only a few volunteer firefighters certified to drive, so if they are not available, a truck won't go out. They are training more drivers.
