**RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF MONROE TOWNSHIP,
FIRE DISTRICT NO. 2 APPOINTING RYAN RICKARDS AS A PROBATIONARY
FIREFIGHTER.**

WHEREAS, N.J.S.A. 40A:14-81.1 provides that a Board of Fire Commissioners may by Resolution appoint persons to paid positions; and

WHEREAS, the Board has completed the process of selection for hiring of a new firefighter, which included physical testing, interview and written testing; and

WHEREAS, as a result of such testing, interviews and evaluations, the Board has identified a person for hire; and

WHEREAS, such hire, however, is conditioned on passing of background checks, physical examinations and other applicable terms and conditions as to be identified by the Chief of the Fire Department.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners of Monroe Township, Fire District No. 2 that:

1. The following individual is conditionally appointed as a firefighter:

Ryan Rickards, Badge Number #227.
2. This appointment is contingent and conditioned on passage of a background check, physical examination and other conditions to be identified by the Chief of the Department, the passage of this Resolution on second reading, and, is subject to a probationary period.
3. This appointment will become effective January 1, 2022. (This date, and the appointment itself, is contingent, however, on the passage of this Resolution on second reading.)
4. The positions will be subject to the laws of this State, applicable personnel policies of the District as well as the Collective Negotiations Agreement between the Board and IAFF Local 3170 and any probationary period or working test period found in those or any applicable source.
